LEGALIZE ABORTION – NOW!

IT'S TIME TO LEGALIZE ABORTION IN GERMANY – NOW. § 218 OF THE GERMAN PENAL CODE MUST BE REMOVED WITHOUT REPLACEMENT AND IT MUST HAPPEN IN THIS LEGISLATIVE PERIOD!

THIS IS NOT ONLY DEMANDED BY AN EXPERT COMMISSION OF THE GOVERNMENT. ACCORDING TO A REPRESENTATIVE SURVEY, 75% OF THE PEOPLE IN GERMANY ARE FOR THE ABOLITION OF § 218. BUT THE GOVERNMENT HAS NOT (YET) ACTED!

Background:

Abortion is a crime in Germany. Although there is no penalty up to the 12th week of pregnancy, pregnant people must seek mandatory counseling and observe a waiting period between counseling and abortion. This disempowers pregnant people! But that's not the only problem: in many places, there is a shortage of doctors and clinics that perform abortions, and health insurance usually does not cover the cost.

This is unacceptable! Pregnant people must be free to decide whether or not to have an abortion! The right to reproductive self-determination is a human right! Abortion must finally be safe, accessible and free in Germany!

But conservatives and right-wingers have other plans: CDU/CSU, AfD and the so-called "pro-life movement" want to restrict the right to abortion even further. A looming right-wing government is therefore an extreme danger for all unwanted pregnant people! Time is pressing: we need legalization now!

That's why, starting on September 16, let's make it clear again and again with various actions for 12 weeks: Abortion must be legalized – now!

What we demand:

Remove § 218 From the Penal Code Without Replacement!

Abortions are not crimes. They must be finally removed from the penal code and not made more difficult by other legal barriers.

Right to Counseling Instead of Mandatory Counseling!

Mandatory counseling is disempowering. Instead, voluntary counseling services are needed everywhere – multilingual, close to home, accessible and non-discriminatory.

Full Coverage of Costs for Everyone!

Currently, abortion is an out-of-pocket service, except in cases of financial hardship. To ensure good access to abortion, it is important that it be free of charge – regardless of insurance status.

How we get there:

From September 16 to December 8, actions will take place all over Germany for 12 weeks – sometimes on social media and sometimes on the streets, sometimes for a few seconds and sometimes for several hours, sometimes alone and sometimes with a lot of people.
